Background

After graduating with a BCom LLB from the University of Otago in 1988, I worked in commercial litigation in Wellington and London commercial firms. I was Senior Crown Counsel with the Crown Solicitor's Office in Christchurch from 1993 to 1997.

I was a partner in Duncan Cotterill's litigation team for 13 years from 1998, and served as Chairman of the firm from 2008 to 2010.

I joined the independent bar in 2011. I was appointed Queen's Counsel in June 2016.

I act for several of New Zealand's major insurers, primarily in the defence of professional service providers. I also conduct cases concerning directors' and officers' liability, public liability, statutory liability and general insurance.

I act against insurers for private clients and companies in the same areas and have resolved disputes concerning life and health insurance issues, and since 2011, business interruption and material damage claims arising out of the Canterbury and Kaikoura earthquakes.
